WHEREAS, on or about 12:00PM, 07 February 2025, a verbal instruction through a mobile phone call was received by Deputy District Commander SP/Lt. Arnulfo C. Villar from the District Collector Port of Limay and the Deputy Commissioner, Enforcement

Group, directing the former to proceed at Dive Industries Inc. in Brgy. Alas-asin, Mariveles, Bataan to assist National Bureau of Investigation (NBI) in conducting Fuel Marking Testing on one (1) vessel and four tank trucks involved in alleged illicit activity regarding suspected vessel and tank trucks carrying smuggled fuel products.

WHEREAS, at around 12:47PM, composite team of ESS-CPD team and SGS MLab 12, driven by Sweden Bacaling, helper Jerenze Salazar along with analyst Rhena Desamparado and MLab 14 driven, by Marvic Mortalla with analyst Jiyasmin Jizel Dela Rosa arrived at Dive Industries Inc. in Brgy. Alas-asin, Mariveles, Bataan.

WHEREAS, upon arrival at the location, the team found one (1) vessel bearing name "M/V EFFRIENE" and eleven (11) tank trucks surrounded by personnel from the NBI headed by Director Jaime B. Santiago.

**WHEREAS**, according to the account of NBI, the operation stemmed from a surveillance of the area, wherein they found one (1) vessel berthing towards Dive Industries' pier resulting to the apprehension of the said vessel along with fifteen (15) personalities conducting siphoning activity from the vessel to the tank trucks.

**WHEREAS**, with the collaboration of ESS-Limay Fuel Marking Team and SGS Mobile Laboratory, the fuels found on the suspected conveyances were subjected to fuel marking tests.

WHEREAS, initial and confirmatory tests yielded "FAIL" results for all the loaded lorry tank trucks including the motor tanker vessel suspected to be the source of the unmarked fuels.

WHEREAS, inquest proceedings were caused by NBI to the alleged crews and drivers/helpers of the tanker vessel and lorry trucks, in violation of Section 1113 (f) (g) and (l) of the Customs Modernization and Tariff Act (CMTA) in relation to Section 107 (Value Added Tax on Importation of Goods), 148 (Excise Tax on Manufactured Oils and Other Fuels) and 148-A (Mandatory Marking of All Petroleum Products) of National Internal Revenue Code, as amended and Violation of Batas Pambansa Blg. 33 as amended subsection 3H by PD 1865, pursuant to Article 45 of thye Revised Penal Code on the confiscation and forfeiture of the proceeds of the instrument of the crime, in relation to Section 13(c) of the Republic Act No. 10867 (National Bureau of Investigation Modernization Act).

WHEREAS, pursuant to a Mission Order issued by the District Collector of the BOC Port of Limay, a composite team from Assessment Division, Enforcement and Security Service (ESS) and Customs Intelligence and Investigation Service (CIIS) were directed to conduct inventory of Diesel product and conveyances involved in the alleged smuggling activities inside Dive Industries Inc.

WHEREAS, in view of the foregoing, the Enforcement and Security Service (ESS) recommended the issuance of a Warrant of Seizure and Detention (WSD) against one (1) vessel "M/V EFFRIENE, four (4) tank trucks loaded with unmarked Diesel, and seven (7) empty tank trucks parked inside Dive Industries Inc., in violation of paragraph A Section 265-A, Section 148-A, and Title X, Section 254 of the NIRC as amended by R.A. 10963 and Section 1401 and Section 1430 of R.A. 10863 otherwise known as the Customs Modernization and Tariff Act of 2016.

WHEREAS, Acting Customs Operations Office III Clarissa Grace A. Apor and Acting Customs Officer V Nerie Paz B. Larin appraised the value of the Diesel Fuel, one (1) vessel "M/V EFFRIENE, four (4) tank trucks loaded with unmarked Diesel, and seven (7) empty tank trucks at One Hundred Ninety-One Million, Nine Hundred Twenty-Four Thousand, One Hundred Four Pesos and Fifteen Centavos (Php191,924,104.15), with the following details, to wit:

No. 10863, otherwise known as the Customs Modernization and Tariff Act ("CMTA"), Sections 148-A, 254, and 265-A of the National Internal Revenue Code ("NIRC"), as amended by R.A. No. 10963, otherwise known as the "Tax Reform for Acceleration and Inclusion Law (TRAIN LAW).

WHEREFORE, by virtue of the authority vested in me by law, and in compliance with pertinent Customs laws, rules and regulations, you together with the representative of this office, are hereby ordered to forthwith seized the aforementioned goods/articles
