WARRANT OF SEIZURE AND DETENTION

To:

ESS-CPD Sector Commander Sub-Port of General Santos

WHEREAS, on 14 January 2025, Regional Highway Patrol Unit 12 (RHPU 12) Special Operation Team, together with RID-12 Tracker Team Foxrot, SOT CIDG-12 and Sarangani PPO, conducted a checkpoint along National Highway, Sitio Siguel, Tinoto, Maasim, Sarangani, which resulted to the seizure of the following, to wit:

WHEREAS, on 15 January 2025, the above-seized articles were turned over by Police Colonel Benito O. Recopuerto, through PLT Rheinan M. Mainar, RHPU 12, and received by SAI Rogel E. Julio, Sector Commander, ESS-CPD, Sub-Port of General Santos, for safekeeping and for purposes of proper disposition;

WHEREAS, on 15 January 2025. Customs Examiner Jovannie D. Prado, submitted a report relative to the conduct of physical examination of the seized items. Customs Examiner Prado issued a certification that the seized goods were considered as smuggled and recommended for the issuance of a Warrant of Seizure and Detention in violation of Section 117, Section 1113 and Section 400 of R.A. No. 10863 otherwise known as the "Customs Modernization and Tariff Act (CMTA)";

WHEREAS, IA-II Michael D. Cariga, Team Leader, CIIS, Sub-Port of General Santos issued a Certification dated 15 January 2025 that as per records, the claimant is not registered or accredited importer with the Bureau of Customs:

WHEREAS, on 30 January 2025, ESS District Commander SP/Capt. Mangurun C. Batuampar, Jr., and CIIS Chief IO-II Felix A. Espino III, also recommended for the issuance of Warrant of Seizure and Detention:



WHEREFORE, by virtue of the authority vested by law in this Office, you are hereby ordered to forthwith SEIZE the aforementioned articles and take into physical possession and, custody thereof Compliance with Customs Administrative Order No.10-2020, particularly, in the manner of making a return of service is likewise prescribed and the submission of inventory Report on the list of the seized cargo is to be strictly observed.
