The Bid Documents can be secured from the Administrative Division Bureau of Customs - Manila International Container Port, Isla Puting Bato, Tondo, Manila with a **Fee of a non-refundable amount of PHP 250.00**, to be paid at the Collection Division, this Port.

The sealed bid to be submitted shall indicate the lot on the face of the envelope, addressed to the Disposal Committee Chairperson. The sealed bid offers shall be submitted to the Disposal Committee together with THE BIDDER'S BOND (BB) in the form of a cash bond AMOUNTING TO 10% OF THE FLOOR PRICE PER LOT. The 10% cash bond shall be forfeited if the winning bid price is not paid in full by the winning bidder within the period prescribed in the Notice of Award. Bidder's Bond shall be in the form of Cash payable to the Bureau of Customs – Manila International Container Port, through the Collection Division. Subject Bidder's Cash Bond will be returned to the non-winning bidders right after the award of the winning bidder. The Bidder's Bond posted by the winning bidder shall form part of the payment of the full amount of the winning bid price.

All payments made will be issued an **official receipt** using Accountable form No. 51-C from the Collection Division, this Port.

All payment proceeds received shall be deposited to the Bureau of Treasury General Fund through BOC (thru authorized agent bank).

The BOC MICP Disposal Committee reserves the right to reject and/or all bids, waive any infirmity contained hereto and accept the offer most advantageous to the government.

The Bureau of Customs-Manila International Container Port assumes no obligation or responsibilities whatsoever to compensate or indemnify any bidder for the expense or loss that may be incurred in the preparation of their bids documents.
