WARRANT OF SEIZURE AND DETENTION

TO: The District Commander
ESS-CPD, Port of Iloilo

WHEREAS, on 9 February 2025 on or about 2330H, the baggage of Korean passenger later on identified as KIM OKKYU, male, born on 03 March 1958, (67 years old) from Incheon, Korea with Passport No. M33241466, on board TW189 from Incheon, Korea was marked "X" during the X-Ray scanning of the check-in baggage and was referred for physical examination to the undersigned.

WHEREAS, before the conduct of physical examination, Customs Examiner JOANNA CARLA I. VERTIDO politely asked the passenger if he has anything to declare. Right then and there, the passenger replied he has with him box of medicine as evidence by a Held Baggage Receipt No. 00480636.

WHEREAS, the physical examination yielded One (1) Box containing Assorted Vitamins, Supplements, and other health supplements intended as maintenance without Doctor's Prescription, with no English Translation, and some are already expired as indicated on the packaging, to wit:

WHEREAS, for failure to present the necessary permit from FDA-DOH, the above items were in the custody of the Customs Examiner who submitted her incident report to Acting Port Collector Melisa P. Andana of the Kalibo International Airport, Aklan.

WHEREAS, Acting Port Collector Andana, submitted a Disposition Form address to Collector Ciriaco DG. Ugay, and recommended for the issuance of Warrant of Seizure and Detention against the subject items for violation of Section 117 of the CMTA and other pertinent Customs Rules and Regulation, and in relation to FDA-DOH Joint Circular No. 1 dated June 22, 2015, importation of FDA-DOH Regulated Products for Personal Use.

WHEREFORE, by virtue of the authority vested by law in this Office, you are hereby ordered to forthwith SEIZED the aforementioned items and take into physical possession and custody thereof. Compliance with the Customs Administrative Order No. 10-2020, particularly, in the manner of making a return of service is likewise prescribed and the submission of an inventory report on the list of the seized items is to be strictly observed.
