**WHEREAS**, on January 02, 2025, at Purok 13, Brgy. Poblacion, Initao, Misamis Oriental, Initao MPS personnel led by PLT Sherwin S. Dala, DCOP, under the supervision of PCAPT Roderlito Sauro Camay, COP, conducted an operation that resulted to the confiscation of undocumented electronic cigarettes in the possession of Jay Lawrence P. Antig;

**WARRANT OF SEIZURE AND DETENTION**

**WHEREAS**, on November 28, 2024, the 1<sup>st</sup> Provincial Mobile Force Company, 2<sup>nd</sup> Platoon led by PLT Jeffrey M. Penaso, Platoon Leader, under the supervision of PLTCOL Ariel Philip Pontillas, Force Commander, conducted an overlapping checkpoint operation that resulted to the flag down of a motorcycle with sidecar loaded with undocumented cigarettes;

**WHEREAS**, the following cigarettes were turned over to the Bureau of Customs-Subport of Mindanao Container Terminal (MCT-SP) for proper inventory and safekeeping pending the issuance of a Warrant of Seizure and Detention (WSD):

**WHEREAS**, in a Disposition Forms dated March 5, 2025, the Port Collector, MCT-SP recommended the issuance of Warrant of Seizure and Detention against the cigarettes since the result of the inventory and physical examination conducted by the assigned Customs Examiner revealed that the cigarettes lack the required Import Commodity Clearance (ICC) from the National Tobacco Administration (NTA), a clear violation of Section 117 and 1113 (f) and (l)-1 of the Customs Modernization and Tariff Act (CMTA) in relation to NTA Memorandum Circular No. 03, series of 2004 and other applicable NTA laws, rules and regulations;

**NOW THEREFORE**, by virtue of the authority vested in this Office in accordance with Republic Act 10863 (Customs Modernization and Tariff Act) and relevant Customs rules and regulations, you are hereby directed to seize **the twenty-seven (27) reams of Delta brand cigarettes, twenty-five (25) reams of Modern brand cigarettes, and three reams of Cannon brand cigarettes** and turn them over to the Property Custodian/Warehouse-in-Charge, this Port, for safekeeping pending termination of the seizure proceedings thereon or until further order from this Office pursuant to and in strict compliance with the provisions of CMO 8-94 particularly on the matter of making a return of service and the submission of the Inventory Report or list of the articles seized.

**WARRANT OF SEIZURE AND DETENTION**

**WHEREAS**, on January 20, 2025, personnel of 3<sup>rd</sup> Platoon, 1003<sup>rd</sup> MC, RMFB 10 Omonay, Damulog, Regional Border Control Point led by PLT Salacodin C. Basser under the supervision of PMAJ Alain G. Jamero (lead unit), Damulog MPS, 2<sup>nd</sup> PMFC, PIU, apprehended suspected smuggled cigarettes on board an Isuzu truck with plate number GHF 976;

**WHEREAS**, the confiscated cigarettes were turned over to the Bureau of Customs-Support of Mindanao Container Terminal (MCT-SP) for proper inventory and safekeeping pending the issuance of a Warrant of Seizure and Detention (WSD):

**WHEREAS**, in two separate Disposition Forms dated March 11, 2025 and February 27, 2025, the District Commander, ESS-CDO and Port Collector, MCT-SP, respectively, recommended the issuance of Warrant of Seizure and Detention against the cigarettes since the result of the inventory and physical examination conducted by the assigned Customs Examiner revealed that the cigarettes lack the required Import Commodity Clearance (ICC) from the National Tobacco Administration (NTA), a clear violation of Section 117 and 1113 (f) and (l)-1 of the Customs Modernization and Tariff Act (CMTA) in relation to NTA Memorandum Circular No. 03, series of 2004 and other applicable NTA laws, rules and regulations;

**NOW THEREFORE**, by virtue of the authority vested in this Office in accordance with Republic Act 10863 (Customs Modernization and Tariff Act) and relevant Customs rules and regulations, you are hereby directed to seize the **thirty-five (35) master cases of Delta Menthol brand cigarettes, nineteen (19) master cases of Modern brand cigarettes, one hundred twenty-five (125) master cases of Delta brand cigarettes (red), and nineteen (19) master cases**, and turn them over to the Property Custodian/Warehouse-in-Charge, this Port, for safekeeping pending termination of the seizure proceedings thereon or until further order from this Office pursuant to and in strict compliance with the provisions of CMO 8-94 particularly on the matter of making a return of service and the submission of the Inventory Report or list of the articles seized.
