Additionally, the abovenamed officials and employees shall be provided with meals and transportation support for on-site activities in the Senate and the House of Representatives, subject to existing budgeting, accounting, and auditing rules and regulations.

The Head of the PDMSG is hereby authorized to issue supplemental orders to cover additional personnel who may be required to provide support during the budget deliberations and other related activities, upon formal request of the concerned Heads of Groups/Offices of this Department.

This Order shall take effect immediately, and all concerned shall be guided accordingly.
