WARRANT OF SEIZURE AND DETENTION

To: The District Commander
ESS-CPD, Port of Davao

WHEREAS, on 23 December 2024, personnel on duty at the Task Force Sirawan joint fixed checkpoint, Brgy. Sirawan, Toril, Davao City, in coordination with Eden Police Station 19, while conducting a regular checkpoint was able to stop a vehicle and saw in plain view smuggled cigarettes on board to the said vehicle which resulted to its seizure, to wit:

WHEREAS, on 23 December 2024, the above-seized articles were turned-over by PSSg Joseph Glined Namoc, from the PNP PRO 11, DCPO, Police Station 19, to the Bureau of Customs, Port of Davao and received by SA-I Amil Rafsanjanni A. Basman, ESS-CPD, for safekeeping and for purposes of proper disposition;

WHEREAS, on 13 February 2025, ESS District Commander SP/Capt. Mangurun C. Batuampar, Jr., and CIIS Chief IO-II Felix A. Espino III, recommended for the issuance of Warrant of Seizure and Detention of the above seized items; and

WHEREAS, on 17 February 2025, Customs Examiner Amer-Hassan G. Mangoyag, Jr., submitted a report relative to the conduct of physical examination of the seized items in the presence of ESS representative, SA-I Amil Rafsanjanni A. Basman and CIIS representative, IO-I Vanne Ishvi A. Lamoste. Customs Examiner Mangoyag recommended for the issuance of a Warrant of Seizure and Detention in violation of Section 117, Section 1113 and Section 400 of R.A. No. 10863 otherwise known as the "Customs Modernization and Tariff Act (CMTA)"; and

WHEREFORE, by virtue of the authority vested by law in this Office, you are hereby ordered to forthwith SEIZE the aforementioned articles and take into physical possession and, custody thereof. Compliance with Customs Administrative Order No.10-2020, particularly, in the manner of making a return of service is likewise prescribed and the submission of inventory Report on the list of the seized cargo is to be strictly observed.
