WARRANT OF SEIZURE AND DETENTION

WHEREAS, on 18 December 2024, CIDG 12 North Cotabato, together with Matalam Police Station, in coordination with the Bureau of Customs, Sub-Port of General Santos, conducted a buy-bust operation at Brgy. New Alimodian, Matalam, North Cotabato which resulted to the seizure of following goods, to wit:

WHEREAS, on 19 December 2024, the above-seized articles were turned over by Police Major Dan Junson V. Espinosa, through Pat. Mark Lester A. Ordonia, from CIDG-North Cotabato, and received by SAI Rogel E. Julio, Sector Commander, ESS-CPD, Sub-Port of General Santos, for safekeeping and for purposes of proper disposition;

WHEREAS, on 19 December 2024, Customs Examiner Jovannie D. Prado, submitted a report relative to the conduct of physical examination of the seized items. Customs Examiner Prado issued a certification that the seized goods were considered as smuggled and recommended for the issuance of a Warrant of Seizure and Detention in violation of Section 117, Section 1113 and Section 400 of R.A. No. 10863 otherwise known as the "Customs Modernization and Tariff Act (CMTA)";

WHEREAS, on 14 February 2025, ESS District Commander SP/Capt. Mangurun C. Batuampar, Jr., and CIIS Chief IO-II Felix A. Espino III, also recommended for the issuance of Warrant of Seizure and Detention; and

WHEREFORE, by virtue of the authority vested by law in this Office, you are hereby ordered to forthwith SEIZE the aforementioned articles and take physical possession and custody. Accordingly, in compliance with Customs Administrative Order No.10-2020, particularly, in the manner of making a return of service and the submission of Inventory Report on the list of the seized cargo be strictly observed.
