WARRANT OF SEIZURE AND DETENTION

WHEREAS, on 29 December 2024, CIDG 12 South Cotabato PFU, together with Koronadal CPS 1<sup>st</sup> SCPMFC and SCPIU, in coordination with the Bureau of Customs, conducted a buy-bust operation in line with their MEGA SHOPPER, a campaign against smuggling, at Macagba St., Purok Maharlika, Brgy, GPS, Korodanal, South Cotabato which resulted to the secture of the following goods, to wit:

WHEREAS, on 02 January 2025, the above-sected articles were turned over by PSSg Eduardo D. Torre, Jr., from CIDG 12-South Colabato, and received by SAI Rogel E. Julio, Sector Commander, ESS-CPD, Sub-Port of General Santos, for safekeeping and for purposes of proper disposition.

WHEREAS, on 02 January 2025, Customs Examiner Jovannie D. Prado, submitted a report relative to the conduct of physical examination of the sected terms. Customs Examiner Prado issued a certification that the seized goods were considered as struggled and recommended for the issuance of a Warrant of Seizure and Detention in violation of Section 117, Section 1113 and Section 400 of R.A. No. 10863 otherwise known as the "Customs Modernization and Tariff Act (CMTA)".

WHEREAS, IA-II Michael D. Canga, Team Leader, CTS, Sub-Port of General Santos issued a Certification deted 02 January 2025 that as per records, the claimant is not registered or accredited importer with the Bureau of Customs,

WHEREAS, on 14 January 2025, ESS District Commander SP/LT Mangurun C. Batuampar, Jr., and CIIS Chief IO-II Felix A. Espino III, also recommended for the issuance of Warrant of Seczure, and

WHEREFORE, by writte of the authority vested by law in this Office, you are hereby ordered to forthwith SEIZE the aforementioned articles and take physical possession and, custody. In compliance with Customs Administrative Order No. 10-2020, particularly, in the manner of making a return of service and the submission of Inventory Report on the list of the seized cargo be strictly observed.
