

4 DESCRIPTION OF GOOD

"GANTRY CAR WASH CW3 KLEAN! STAR"

Based on the brochure, technical specifications, operating instructions, and photograph of the product submitted, subject article is an automated vehicle cleaning system. It mainly consists of a washing bay [equipped with, among others, nozzles and spray arches, brushes, wheel washing unit, and dryer], control cabinet, dosing pumps, and sensors. Capable of washing and drying various vehicle sizes and track widths, subject article has the following specifications:

Washing Height (mm)	2100 - 2900
Drive-through Width (mm)	2450 / 2600
Fresh Water Connection, Volume (I/min)	80
Fresh Water Connection, Pressure (bar)	4
Voltage (V)	400
Frequency (Hz)	50

5 REASONS FOR CLASSIFICATION

Heading 84.79 of the ASEAN Harmonised Tariff Nomenclature (AHTN) 2022 covers machines and mechanical appliances having individual functions, not specified or included elsewhere in this Chapter. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that this heading is restricted to machinery having individual functions, which: (a) Is not excluded from this Chapter by the operation of any Section or Chapter Note; and (b) Is not covered more specifically by a heading in any other Chapter of the Nomenclature; and (c) Cannot be classified in any other particular heading of this Chapter since: (i) No other heading covers it by reference to its method of functioning, description or type; and (ii) No other heading covers it by reference to its use or to the industry in which it is employed; or (iii) It could fall equally well into two (or more) other such headings (general purpose machines).

In view thereof, subject article is classified under AHTN 2022 subheading 8479.89.69, with a Most Favoured Nation (MFN) rate of duty of 1% ad valorem.

This ruling shall be valid for five years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.



4 DESCRIPTION OF GOOD

"ROTORK® ELECTRIC ACTUATOR, Model Nos.: IQD 10, IQD 12, IQD 18, IQD 20, IQD 25, IQDL 10, IQDL 12, IQDL 18, IQDL 20, and IQDL 25"

Based on the brochures and technical specifications submitted, subject articles are electric valve actuators designed for local and remote electrical operation of valves. These comprise of a direct current (DC) motor, reduction gearing, reversing starter with local controls and indication, and turns and torque limitation with electronic logic controls and monitoring housed in a watertight enclosure. Using an electric motor to control the movement of a valve by converting electrical energy into mechanical energy, subject articles have the following specifications:

5 REASONS FOR CLASSIFICATION

Heading 85.01 of the AHTN 2022 covers electric motors and generators (excluding generating sets). The pertinent Harmonized System (HS) Explanatory Notes (EN) state that electric motors are machines for transforming electrical energy into mechanical power. This group also includes valve actuators, electrical, consisting of an electric motor with reducing gear and drive shaft and, in some cases, with various devices (electric starter, transformer, hand-wheel, etc.) to operate the valve plug.

In view thereof, subject articles are classified under AHTN 2022 subheading 8501.31.70, with a Most Favoured Nation (MFN) rate of duty of zero; ASEAN-China Free Trade Area (ACFTA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "E"; and Regional Comprehensive Economic Partnership (RCEP) Agreement rate of duty of zero, subject to submission of CO Form "RCEP" or Declaration of Origin (DO) issued by an Approved Exporter.

This ruling shall be valid for five years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.



4 DESCRIPTION OF GOOD

"7629413 FAN MOTOR MAGNETEK 208-230V"

Based on the product brochures submitted, subject article is a single-phase, alternating current (AC) fan motor equipped with a capacitor. Designed to cool off the condenser coils and ensure that internal conditions are low enough to support ice production, subject article is a spare part for an ice machine and has the following specifications:

5 REASONS FOR CLASSIFICATION

Heading 85.01 of the ASEAN Harmonised Tariff Nomenclature (AHTN) 2022 covers electric motors and generators (excluding generating sets). The pertinent Harmonized System (HS) Explanatory Notes (EN) state that electric motors are machines for transforming electrical energy into mechanical power. This group includes rotary motors and linear motors. Rotary motors produce mechanical power in the form of a rotary motion. They are of many types and sizes according to whether they operate on DC or AC, and according to the use or purpose for which they are designed. The motor housing may be adapted to the circumstances in which the motor will operate (e.g., dust proof, drip proof or flame proof motors; non-rigid mountings for belt driven motors, or for motors which will be subject to much vibration).

In view thereof, subject article is classified under AHTN 2022 subheading 8501.40.11, with a Most Favoured Nation (MFN) rate of duty of zero.

This ruling shall be valid for five years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.
