

#### 4 DESCRIPTION OF GOOD

#### "SODIUM BICARBONATE"

Based on the Certificate of Product Registration from the Bureau of Animal Industry (BAI), manufacturing process flow diagram, material safety data sheet, and product label submitted, subject article is pure sodium bicarbonate (NaHCO<sub>3</sub>) in the form of a water-soluble, white crystalline powder. Packed in 25-kg bags, subject article is added to the feeds of cattle, swine, and poultry to regulate muscle contractions and nerve transmissions, help maintain proper balance of water and body fluids, and support treatment of dehydration due to heat stress.

## 5 REASONS FOR CLASSIFICATION

Heading 28.36 of the AHTN 2022 covers, among others, carbonates. The pertinent Harmonized System (HS) Explanatory Notes (EN) state that subject to the exclusions mentioned in the introduction to this sub-Chapter, this heading covers, among others, carbonates (neutral carbonates, hydrogencarbonates or bicarbonates, basic carbonates) - metal salts of the non-isolated carbonic acid (H<sub>2</sub>CO<sub>3</sub>), whose anhydride (CO<sub>2</sub>) falls in heading 28.11. This group includes sodium hydrogencarbonate (acid carbonate, sodium bicarbonate) (NaHCO<sub>3</sub>). Usually a crystalline powder or white crystals, soluble in water, especially when hot, and liable to deteriorate in a humid atmosphere. Used in medicine (for treating gravel); for manufacturing digestive tablets and aerated beverages; in the preparation of baking powders; in the porcelain industry, etc.

In view thereof, subject article is classified under AHTN 2022 subheading 2836.30.00, with a Most Favoured Nation (MFN) rate of duty of zero; ASEAN-China Free Trade Area (ACFTA) rate of duty of zero, subject to submission of Certificate of Origin (CO) Form "E"; and Regional Comprehensive Economic Partnership (RCEP) Agreement rate of duty of zero, subject to submission of CO Form "RCEP" or Declaration of Origin (DO) issued by an Approved Exporter.

This ruling shall be valid for five years from the date of issuance and shall continue to apply unless the law, facts, or circumstances supporting this ruling have changed.
