

## To: All Collectors of Customs Importers, Customs Brokers, Brokers' Representatives and All Others Concerned



In line with Customs Memorandum Order No. 14 - 2019, the Exchange Rate duly issued by the Bangko Sentral ng Pilipinas on 09 May 2025 shall be the applicable Rate of Exchange for the week 10 May 2025 to 16 May 2025 for both the regular consumption entries (formal and informal), warehouse entries as well as withdrawal entries for shipments entered under warehousing.
