DECREE OF ABANDONMENT

WHEREAS, on 24 and 31 March 2025, Warehouseman III, Marion S. Buenaventura conducted an inventory at the Customs In-Bond Baggage Room (CBR) and Interline Baggage Room (IBR), respectively, and found thirty-seven (37) unclaimed goods, all of which have been stored at the facility for over thirty (30) days;

WHEREAS, on 22 April, 2025, this Office received a Disposition Forms from Mrs. Corazon S. Rapa and Mr. Marion S. Buenaventura, Acting Chief of Passenger Service and Processing Division and Warehouseman III, through Atty. Danilo G. Ballena, Jr., Acting Deputy Collector for Passenger Service, recommending the issuance of Decree of Abandonment against the thirty-seven (37) unclaimed goods in the CBR and IBR pursuant to Sections 10.4 and 11.4 of Customs Administrative Order (CAO) No. 1-2017;

WHEREAS, Sections 10.4 and 11.4 of CAO No. 1-2017 provides, to wit:

10.4. All Interline Baggage, which remain unclaimed after thirty (30) days from arrival shall be subject to abandonment proceedings.

11.4. All In-bond Baggage, which remain unclaimed after thirty (30) days from arrival shall be subject to abandonment proceedings.

WHEREAS, the thirty-seven (37) goods identified below are deemed abandoned pursuant to the above-mentioned provisions of law, to wit:
