CUSTOMS MEMORANDUM ORDER

NO. 03-2025

SUBJECT: AMENDMENT TO SECTION 8 "ASEAN REGIONAL EXPERTS" OF CUSTOMS MEMORANDUM ORDER (CMO) NO. 22 – 2021 DATED MAY 20, 2021, ENTITLED "GUIDELINES FOR SELECTION OF NATIONAL CUSTOMS SUBJECT MATTER EXPERTS, RESOURCE PERSONS, TRAINERS, AND LECTURERS, AND NOMINATION FOR THE ASEAN REGIONAL CUSTOMS EXPERTS"

Section 1. Introduction. This is to modify the requirements for the nomination of the Bureau to the Association of Southeast Asian Nations (ASEAN) Regional Expert.

Section 2. Scope. This policy applies to all permanent employees of the Bureau of Customs (BOC) who are covered under CMO 22 – 2021.

Section 3. Objectives. This Order is being issued to ensure compliance with the goals and objectives of the ASEAN Customs Capacity Building Working Group (CCBWG) Strategic Plan of Customs Development (SPCD) for Human Resource Development and Administration (HRDA).

Section 4. Amendment of Section 8, CMO 22 – 2021 "ASEAN REGIONAL EXPERTS". Section 8 of CMO 22-2021 is hereby amended to read as follows:

"Section 8. ASEAN REGIONAL CUSTOMS EXPERT. All BOC National Subject Matter Experts (SMEs), who were found qualified under Section 4 of CMO No. 02-2022, shall be nominated as ASEAN Regional Experts."

Section 5. Effectivity. This Order shall take effect immediately and shall last until revoked.
