Highlights of the Proceedings

- Atty. Roswald Joseph J. Pague, Vice-Chairperson of the Auction and Cargo Disposal Division (ACDD), called the Public Auction to order at 1:30 p.m in the afternoon.
- Six (6) members out of seven (7) ACDD Committee were present, which constituted a quorum.
- Also, the Vice-Chairperson also acknowledged the presence of the representatives from the Commission on Audit (COA) and the bidder who attended via zoom.
- The ACDD Secretariat read the terms and conditions of the auction proceedings and confirmed to Atty. Roswald Joseph J. Pague, Vice-Chairperson, that the Notice of Public Auction was posted on the official Bureau of Customs website and Port of Davao Facebook page.
- The ACDD Committee declared JA HALASAN CUSTOMS BROKERAGE eligible to participate on the public auction proceedings.
- To expedite the proceedings, the ACDD Committee declared failed bidding for the following sale lots, to wit:

8. The Chairperson reminded the winning bidder to pay the remaining price balance within 24 hours after the public auction. Should the winning bidder fail to pay the above-said amount within the prescribed period it will cause the forfeiture of the bond without prejudice to any sanction that the ACDD may impose.
9. Besides, in case such payment has not been made, the subject good/s shall be re-offered three (3) working days for non-perishable goods and the next working day for perishable goods unless the Commissioner provides a different period and subject further to compliance with the publication requirements of CAO 03-2020.
10. The Presiding Officer concluded the proceedings by thanking the Auction Committee, representatives from the COA, and the bidder for a successful public auction. Given the foregoing, the Committee convened for a second bidding for the 4th re-offer of Sale Lot Nos. 27-2023-01B and 27-2023-01D which underwent failed biddings.
11. As there were no further items on the business calendar, Atty. Roswald Joseph J. Pague moved to adjourn the proceedings, duly seconded by the members of ACDD. The Chairperson adjourned the auction proceedings at 2:30 PM.

Terms and Conditions of On-line Public Auction:

1. The conduct of the public auction shall be made through On-Line System.
2. The on-line filing and submission of documentary requirements shall be made at least two (2) days prior to the day of auction to this e-mail at acdddavao@gmail.com. All prospective bidders, whether natural or juridical persons, shall submit the following to said e-mail, to wit:
 - a. Bidder's Registration Form (with name, address and TIN);
 - b. Latest certified true copy of Income and/or Business Tax Returns duly stamped and received by the Bureau of Internal Revenue (BIR) with a validated tax payment made thereon;
 - c. Certified true copy of Mayor's permit/ Business permit;
 - d. Certified true copy of DTI Registration/ SEC Articles of Incorporations (for Corp./Inc./Coop);
 - e. Scanned copy of BOC Official Receipt of Registration Fee (Php 5,050.00);
 - f. Certificate of Accreditation or License from a Regulatory Agency (if applicable);
 - g. Affidavit of Undertaking that the bidder is not the owner or representative of the owner of the items to be sold at public auction;
 - h. Proof of authority to represent principal (e.g. Special Power of Attorney/Board Resolution) for the specific auction sale
 - i. Valid government issued ID of the participant who will actually participate in the online auction;
 - j. Scanned copy of BOC Official Receipt of the 20% Bond posted in a particular lot offered for auction; and
 - k. The prospective bidder shall indicate in the Bidder's Registration Form the specific sale lot numbers they are interested to participate.

The bond shall be refunded to the losing bidder after the closing of the auction. However, the bond shall not be required when the floor price of a sale lot is Php10,000.00 or less.

5. Payments with Cashier's / Manager's Check / Cash to the BOC / Port of Davao shall bear the following:
 - a. Pay to the order of Land Bank of the Philippines-BOC E.O. IFO BOC FAO;
 - b. For the credit of the Bureau of Customs;
 - c. For the account of: _____; Bidder
6. Failure to submit and sign any documentary requirements shall automatically disqualify the registered bidder from participating further in the public auction.
7. Since the Auction is conducted on line via zoom, all qualified bidders shall submit/tender bids via online to the designated email (acdddavao@gmail.com) on the day of the Auction with the presence of the COA representative. The highest bid shall be declared as the winner except when clustering occurs.
8. At the end of each bidding, the bond posted by the winning bidder shall automatically be considered part of the bid price. The fifty percent (50%) of the bid price shall be paid on the spot upon announcement of the winning bid as duly certified by the ACDD Committee and the COA representative. The remaining balance of 50% shall be paid on the succeeding business day.
9. In case such payment has not been made, the subject good/s shall be re-offered three (3) working days for non-perishable goods and the next working day for perishable goods unless the Commissioner provides a different period and subject further to compliance with the publication requirements of CAO 03-2020.
10. A failed bidding shall be declared by the Auction Committee when any of the following circumstances occurs:
 - a. When there is no sealed bid;
 - b. When the highest bidder fails to comply with any of the payments required under Section 5.10 of CAO 03-2020, said bidder shall be disqualified from participating further in the auction sale and, when applicable, the negotiated sale thereof without prejudice to the forfeiture of the minimum deposit and any payment made and imposition of other sanctions as may be warranted.

When the winning bidder fails to claim the items or lot awarded to him within thirty (30) calendar days from the date of award, upon due notice, he shall deem to have abandoned said goods and to have renounced all his rights to it, including forfeiture of all payments made thereon, except upon justifiable reasons, as determined by the District Collector, upon recommendation of the Committee.
12. Representatives from ACDD, ESS, POS, OCOM, CIIS, ODC and COA shall be invited to witness the release.
