**WARRANT OF SEIZURE AND DETENTION**

To: ESS-CPD  
Sector Commander  
Sub-Port of General Santos

WHEREAS, on 05 February 2025, Kidapawan City Police Station, RID 12 Tracker Team Golf/Foxrot, 1203MC RMFB 12, conducted a joint checkpoint operation at Bravo Coy 39 IB PA Task Force Kidapawan located at Purok Rambutan, Brgy. Paco, Kidapawan City. A vehicle was flagged down and upon inspection, cigarettes were seen in plain view inside the vehicle which resulted to its seizure, to wit:

WHEREAS, the above seized cigarettes were turned over by PSMS Anthony M. Pamaylaon, from Kidapawan City Police Station on 07 February 2025 and the seized vehicle was turned over by PCPL Bernie C. Malud last 24 February 2025, and received by SAI Rogel E. Julio, Sector Commander, ESS-CPD, Sub-Port of General Santos, for safekeeping and for purposes of proper disposition;

WHEREAS, IA-II Michael D. Cariga, Team Leader, CIIS, Sub-Port of General Santos issued a Certification dated 07 February 2025 that as per records, the claimant is not a registered or accredited importer with the Bureau of Customs;

WHEREAS, on 07 February 2025 and 24 February 2025, COO-III Jovannie D. Prado, assigned Customs Examiner, submitted a report relative to the conduct of physical examination of the seized cigarettes and the seized vehicle, respectively. Customs Examiner Prado issued a certification that the seized goods were considered as smuggled and recommended for the issuance of a Warrant of Seizure and Detention in violation of Section 117, Section 1113 and Section 400 of R.A. No. 10863 otherwise known as the "Customs Modernization and Tariff Act (CMTA)";

WHEREAS, on 26 March 2025, ESS District Commander SP/Capt. Mangurun C. Batuampar, Jr., and CIIS Chief IO-II Felix A. Espino III, also recommended for the issuance of Warrant of Seizure and Detention; and

WHEREFORE, by virtue of the authority vested by law in this Office, you are hereby ordered to forthwith SEIZE the aforementioned articles and take physical possession and, custody. In compliance with Customs Administrative Order No.10-2020, particularly, in the manner of making a return of service and the submission of Inventory Report on the list of the seized cargo be strictly observed.
