WARRANT OF SEIZURE AND DETENTION

To: The District Commander
ESS-CPD, Port of Davao

WHEREAS, on 15 March 2024, personnel of MARPSTA, Davao City led by PSMS Jayson Kent L. Jadreque and 5th SOU Davao City led by PSSG Adonis Christian L. Geralde conducted a police operation at Bangoy Street, Sta. Ana, Davao City, which resulted to the seizure of the following smuggled cigarettes, to wit:

WHEREAS, on 18 March 2025, the above-seized articles were turned-over by Pat. Emran R. Misquinan, PNP RMU 11, Davao City and received by SA1 Raymond L. Salazar, ESS-CPD representative, Port of Davao; for safekeeping and for purposes of proper disposition;

WHEREAS, 02 April 2025, an examination was conducted by COO III Nancy V. Ampig who submitted a report relative to the conduct of physical examination of the seized items in the presence of IO1 Shaif Macmod C. Guro and SA1 Raymond L. Salazar, ESS-CPD.

WHEREAS, on 11 April 2025, ESS District Commander SP/Capt. Mangurun C. Batuampar, Jr., and CIIS Chief IO-II Felix A. Espino III, recommended for the issuance of Warrant of Seizure and Detention of the above seized items.

WHEREFORE, by virtue of the authority vested by law in this Office, you are hereby ordered to forthwith SEIZE the aforementioned articles and take physical possession and, custody. In compliance with Customs Administrative Order No.10-2020, particularly, in the manner of making a return of service and the submission of Inventory Report on the list of the seized cargo be strictly observed.
