In the May 5, 2025, Memorandum from Chief, Auction and Cargo Disposal Division, this Port, the foregoing list of overstaying loose cargo shipments which were temporarily stored in the empty container have exceeded the prescribed number of days mandated by the CMTA and was reported abandoned inside CFS2 ICTSI premises.

Thus, the above-described shipments are deemed abandoned pursuant to Section 1129 of the CMTA, which provides:


*"Sec.1129. Abandonment, Kinds and Effects of.-
Imported Goods are deemed abandoned under any of the
following circumstances:*

WHEREFORE, by virtue of the authority vested in me by the law, the above-described vehicle is hereby **ABANDONED** in favor of the government to be disposed of in the manner provided for by law.

Let copies of this Consolidated Decree of Abandonment be furnished to all parties and offices concerned for their information and guidance.
