WARRANT OF SEIZURE AND DETENTION

WHEREAS, on 20 March 2025, RPDEU together with Kabacan Municipal Police Station responded to a report that a ten-wheeler wing van truck with plate CDK 2331 carrying smuggled cigarettes will pass through along the highway of Cotabato Province. Upon continued monitoring, the said truck was seen at Sitio Malabuaya, Kayaga, Kabacan, Cotabato which resulted to its seizure of the following, to wit:

WHEREAS, on 24 March 2025, the above seized cigarettes and vehicle were turned over by PSMS Delir L. Parcon, from Kabacan Municipal Police Station, and received by SAI Rogel E. Julio, Sector Commander, ESS-CPD, Sub-Port of General Santos, for safekeeping and for purposes of proper disposition;

WHEREAS, on 24 March 2025, COO-II Vivian A. Jimenez, assigned Customs Examiner, submitted a report relative to the conduct of physical examination of the above seized goods. Customs Examiner Jimenez issued a certification that the seized goods were considered as smuggled and recommended for the issuance of a Warrant of Seizure and Detention in violation of Section 117, Section 1113 and Section 400 of R.A. No. 10863 otherwise known as the "Customs Modernization and Tariff Act (CMTA)";

WHEREAS, on 14 April 2025, ESS District Commander SP/CAPT. Mangurun C. Batuampar, Jr., and CIIS Chief IO-II Felix A. Espino III, also recommended for the issuance of Warrant of Seizure; and

WHEREFORE, by virtue of the authority vested by law in this Office, you are hereby ordered to forthwith SEIZE the aforementioned articles and take physical possession and, custody. In compliance with Customs Administrative Order No.10-2020, particularly, in the manner of making a return of service and the submission of Inventory Report on the list of the seized cargo be strictly observed.
