**WARRANT OF SEIZURE AND DETENTION**

To: The District Commander  
ESS-CPD, Port of Davao

WHEREAS, on 15 March 2025, 5<sup>th</sup> SOU, Davao Intel Monitoring Team, together with Davao City MARPSTA, conducted a buy bust operation on the alleged trading of smuggled trading at Uyanguren St., Sta. Ana, Davao City which resulted to the seizure of the following, to wit:

WHEREAS, on 18 March 2025, the above-seized articles were turned-over by Pat Jovanie S. Keleste, from the PNP Maritime Group, 5<sup>th</sup> Special Operation Unit to the Bureau of Customs, Port of Davao and received by SA-I Raymond L. Salazar, ESS-CPD, for safekeeping and for purposes of proper disposition;

WHEREAS, on 02 April 2025, Customs Examiner Nancy V. Ampig, submitted a report relative to the conduct of physical examination of the seized items in the presence of SA-I Raymond L. Salazar, ESS representative and IO-I Shaif Macmod C. Guro, CIIS representative. Customs Examiner Ampig recommended for the issuance of a Warrant of Seizure and Detention in violation of Section 117, Section 1113 and Section 400 of R.A. No. 10863 otherwise known as the "Customs Modernization and Tariff Act (CMTA)"; and

WHEREAS, on 07 April 2025, ESS District Commander SP/CAPT. Mangurun C. Batuampar, Jr., and CIIS Chief IO-II Felix A. Espino III, recommended for the issuance of Warrant of Seizure and Detention of the above seized items.

WHEREFORE, by virtue of the authority vested by law in this Office, you are hereby ordered to forthwith SEIZE the aforementioned articles and take physical possession and, custody. In compliance with Customs Administrative Order No.10-2020, particularly, in the manner of making a return of service and the submission of Inventory Report on the list of the seized cargo be strictly observed.
