WARRANT OF SEIZURE AND DETENTION

To: The District Commander ESS-CPD, Port of Davao

WHEREAS, on 19 November 2024, personnel of Regional Operations Group 11 (RSOG XI) and City Special Operations Group 11 led by P/LT Richard Dionisio and P/LT COL Stefanio A. Rabino conducted a Buy-Bust Operation at Jomat Bldg., JP Laurel Avenue, Brgy. Angliongto Davao City which resulted to the apprehension of Jeson B. Valdez and Benzal A. Hashim and seizure of the following smuggled cigarettes, to wit:

WHEREAS, on 21 November 2024, the above-seized articles were turned-over by PMSG Shiela Mae Vidal and received by SA1 Rafsanjanni A. Basman, ESS-CPD representative, Port of Davao, and witnessed by SA1 Mark Paulo G. Delfin, COOIII Lope G. Maglana, Jr. for safekeeping and for purposes of proper disposition;

WHEREAS, on 2 April 2025, an examination was conducted by COO III Lope G. Maglana, Jr. who submitted a report relative to the conduct of physical examination of the seized items in the presence of SA1 Rafsanjani A. Basman, ESS-CPD and SA1 Mark Paulo G. Delfin. CIIS.

WHEREAS, on 11 April 2025, ESS District Commander SP/CAPT. Mangurun C. Batuampar, Jr., and CIIS Chief IO-II Felix A. Espino III, recommended for the issuance of Warrant of Seizure and Detention of the above seized items.



WHEREFORE, by virtue of the authority vested by law in this Office, you are hereby ordered to forthwith SEIZE the aforementioned articles and take physical possession and, custody. In compliance with Customs Administrative Order No.10-2020, particularly, in the manner of making a return of service and the submission of Inventory Report on the list of the seized cargo be strictly observed.
