**WARRANT OF SEIZURE AND DETENTION**

To: ESS-CPD

WHEREAS, on 22 February 2025, joint personnel of CIDG 12 North Cotabato PFU and Tulunan MPS conducted a Buy-Bust Operation at Barangay Bual, Tulunan, North Cotabato which resulted to the arrest of Arjon Ray Pacal Castillon and seizure of the following smuggled cigarettes, to wit:

WHEREAS, on 24 February 2025, the above-seized articles were turned-over by Patrolman Rey Carlo S. Guerrero, CIDG North Cotabato, and received by SA1 Rogel E. Julio, Sector Commander, ESS, Subport of General Santos and witnessed by ESS and CIIS Representatives for safekeeping and for purposes of proper disposition;

WHEREAS, on 24 February 2025, an examination was conducted by COO III Jovannie O. Prado, who submitted a report relative to the conduct of physical examination of the seized items in the presence of ESS and CIIS representatives and Pat. Rey Carlo S. Guerrero.

WHEREAS, on 11 April 2025, ESS District Commander SP/CAPT. Mangurun C. Batuampar, Jr., and CIIS Chief IO-II Felix A. Espino III, recommended for the issuance of Warrant of Seizure and Detention of the above seized items.



WHEREFORE, by virtue of the authority vested by law in this Office, you are hereby ordered to forthwith SEIZE the aforementioned articles and take physical possession and, custody. In compliance with Customs Administrative Order No.10-2020, particularly, in the manner of making a return of service and the submission of Inventory Report on the list of the seized cargo be strictly observed.
