NOTICE TO FILE GOODS DECLARATION/ENTRY, TO PAY DUTIES AND TAXES AND TO CLAIM GOODS FOR SHIPMENTS AT THE UNITED PARCEL SERVICE (UPS), PORT OF CLARK

This serves as a Notice to File Entry, Pay Duties and Taxes and Claim the Goods for the attached list of abandoned/overstaying cargoes at the United Parcel Service (UPS) Warehouse, Port of Clark.

Pursuant to Section 1129 of RA 10863 – Customs Modernization and Tariff Act (CMTA), this office hereby sends this Notice to File Entry to the consignees listed herein whose shipment have been discharged but have not filed the corresponding goods declaration. DISCUSSION:

- On July 5, 2024, Mr. Marlon Sipin, Brokerage Manager of UPS, submitted a list of overstaying goods at UPS, accompanied by a Certification stating that, despite a series of notifications, the consignees failed to file the necessary entry and pay the required duties and taxes. Hence, the goods remained unclaimed.
- On June 19, 2025, Mr. Basher M. Samporna, Warehouseman of the UPS Composite Unit, submitted a partial list of overstaying goods, consisting of 19 airway bills, and certified that the said goods are still intact at the UPS Warehouse.
- On June 27, 2025, Mr. Samporna submitted another list of overstaying goods, consisting of 38 airway bills, and likewise certified that the goods are still intact at UPS warehouse. The submitted list is attached as Annex A.
- On July 3, 2025, the list of overstaying goods was forwarded to the Public Information
 Officer for posting at the BOC official website and various social media accounts of
 the Port of Clark.
