WARRANT OF SEIZURE AND DETENTION

WHEREAS, a shipment of 1x40 container no. FSCU5848652 stc: egg noodle, frozen croissant dough, frozen dough buns, pizza dough and spring rolls covered by Bill of Lading No. HK2514SCD360R and consigned to Latinx Consumer Goods Trading arrived at the Mindanao Container Terminal Subport on May 26, 2025 on board the vessel MV SITC HONGKONG V.2514S;

WHEREAS, on June 11, 2025, acting on the derogatory information received from Bureau of Plant Industry (BPI), a spot-check inspection was conducted on the subject shipment by the assigned Customs Examiner, in the presence of representatives from Customs Intelligence & Investigation Service (CIIS), Enforcement and Security Service (ESS), X-Ray Inspection Project (XIP), Chamber of Customs Brokers Inc. (CCBI) and Bureau of Plant Industry (BPI) and was found to contain red onions;

WHEREAS, issuance of Warrant of Seizure and Detention against the shipment was recommended for violation of Section 1400 of the CMTA in relation to Sections 117 and 1113 of the CMTA;

NOW THEREFORE, by virtue of the authority vested in this Office in accordance with Republic Act 10863 (Customs Modernization and Tariff Act) and relevant Customs rules and regulations, you are hereby directed to seize the **red onions** and turn them over to the Property Custodian/Warehouse-in-Charge, this Port, for safekeeping pending termination of the seizure proceedings thereon or until further order from this Office pursuant to and in strict compliance with the provisions of CMO 8-84 particularly on the matter of making a return of service and the submission of the Inventory Report or list of the articles seized.
