GREETINGS:

**WHEREAS**, a shipment of 1x40' container bearing Container Van No. FFAU6574694, stc: five hundred (500) cartons of wood pulp, covered by Bill of Lading No. SITSVMSG013606, arrived at the Port of Manila from Cambodia on 21 June 2025;

**WHEREAS**, Alert Order No. A/POM/0/20250626-0020 dated 26 June 2025 was issued against the subject shipment;

**WHEREAS**, on 02 July 2025, the assigned customs examiner together with CIIS, ESS and importer's representatives conducted examination of the subject shipment and was found to actually contain five hundred one (501) sacks of tobacco;

**WHEREAS**, in a Disposition Form dated 14 July 2025, the assigned customs examiner recommended the issuance of a Warrant of Seizure and Detention (WSD) against the subject shipment for misdeclaration and lack of Import Commodity Clearance from the National Tobacco Administration (NTA);

**WHEREAS**, the foregoing circumstances show the existence of probable cause for the issuance of a WSD against the subject shipment pursuant to Sections 1400, 117 and 1113 of the Customs Modernization and Tariff Act (CMTA), in relation to NTA Board Resolution No. 079-2005, otherwise known as the "Amended Rules and Regulations Governing the Exportation and Importation of Leaf Tobacco and Tobacco Products";

**WHEREAS**, the articles/items are presently stored at ATI Container Yard.

**WHEREFORE**, by virtue of the authority vested in me by law, and in compliance with pertinent Customs laws, rules and regulations, you, together with the representative of this office, are hereby ordered to forthwith seize the aforementioned articles and turn them over to the custody of the Auction and Cargo Disposal Division of this Port, in compliance with Customs Administrative Order (CAO) No. 10-2020 and CAO No. 3-2019, particularly on the matter of making a return of service and the submission of the inventory report or list of the article/s seized is to be strictly observed and **finally, you are hereby ordered to return the aforesaid Warrant within twenty-four (24) hour from service, to the Law Division, this Port. Failure to do so, the Warrant shall ipso facto be considered null and void.**

**DISCUSSION**

- This refers to Alert Order issued against the shipment declared WOOD PULP consigned to ACES INTERNATIONAL CONSUMER GOODS TRADING covered by Import Entry No. C-93842-25.
- On June 26, 2025, Alert Order No. A/POM/0/20250626-0020 was issued by the Office of the District Collector (ODC) against the subject shipment based on suspected violation of Section 1400 "Misdeclaration, Misclassification, Undervaluation in Goods Declaration" in relation to Section 1113 "Property Subject To Seizure And Forfeiture" of Republic Act No. 10863 otherwise known as the "Customs Modernization and Tariff Act" (CMTA) and National Tobacco Administration Board Resolution No. 079-2005 or the Amended Rules and Regulations governing the Exportation and Importation of Leaf Tobacco and Tobacco Products pursuant to Executive Order No. 245.

3. The assigned examiner received the Alert Order Notice together with the Memorandum from the District Collector directing the former to conduct 100% physical examination to determine the alleged violation.
4. On July 02, 2025, the examination was conducted by the customs examiner in the presence of the Importer's representative and representatives of the CIIS, ESS, and XIP, who all served as witnesses during the examination. Attached herewith are the pictures taken during the examination.
5. Accordingly, the Examination Report were accomplished by the assigned customs examiner with the following findings and recommendations:

6. Upon examination, it was found to contain 501 sacks of Tobacco without Import Commodity Clearance from National Tobacco Administration. This is in violation of National Tobacco Administration Board Resolution No. 079-2005 or the Amended Rules and Regulations Governing the Exportation and Importation of Leaf Tobacco and Tobacco Products Pursuant to Executive Order No. 245 and Section 117 of Republic Act No. 10863 otherwise known as Customs Modernization and Tariff Act (CMTA).
7. Moreover, in view of the above findings of misdeclaration, the Examiner recommended the issuance of Warrant of Seizure and Detention (WSD) pursuant to Section 1400 of the CMTA which states, to wit:

*"When the misdeclaration, misclassification or undervaluation is intentional or fraudulent, such as when a false or altered document is submitted or when false statements or information are knowingly made, a surcharge shall be imposed equivalent to five hundred percent (500%) of the duty and tax due and that the goods shall be subject to seizure regardless of the amount of the discrepancy without prejudice to the application of fines or penalties provided under Section 1401 of this Act against the importer and other person or persons who willfully participated in the fraudulent act."*

8. In addition, Section 1113, paragraph (f) and (i) of the CMTA, provides that:

*"(f) Goods, the importation or exportation of which are effected or attempted contrary to law, or any goods of prohibited importation or exportation, and all other goods which, in the opinion of the District Collector, have been used, are or were entered to be used as instruments in the importation or the exportation of the former;*

XXX

*(i) Any package of imported goods which is found upon examination to contain goods not specified in the invoice or goods declaration including all other packages purportedly containing imported goods similar to those declared in the invoice or goods declaration to be the contents of the misdeclared package."*

## RECOMMENDATION

9. Respectfully submitted for the approval of the District Collector for issuance of Warrant of Seizure and Detention (WSD) against the entire shipment.
