WARRANT OF SEIZURE AND DETENTION

WHEREAS, a shipment of 1x40 container no. DFSU7473415 stc. 1,086 pkgs. of mirror with frame covered by Bill of Lading No. SITGWZCDC010382 and consigned to Vinetee Trezz Trading Corp. arrived at the Mindanao Container Terminal Subport on July 15, 2025 on board the vessel SITC LICHENG 2514S;

WHEREAS, on July 14, 2025, Pre-Lodgment Control (PLCO) No. P/CDO/O/2025714-0002 was issued against the shipment for possible violation of Section 118 (f) in relation to Section 1400 and Section 1401 of the CMTA;

WHEREAS, on July 23-24, 2025, a 100% physical examination was conducted on the subject shipment by the assigned Customs Examiner, in the presence of representatives from Customs Intelligence & Investigation Service (CIIS) and Enforcement and Security Service (ESS) and was found to contain 68 cartons of mirror with frame and various general merchandise (see attached examination report);

WHEREAS, issuance of Warrant of Seizure and Detention against the shipment was recommended for violation of Section 118 (f), Section 119 (b), Section 1113 (f) and (i) in relation to Section 1400 of the CMTA;

NOW THEREFORE, by virtue of the authority vested in this Office in accordance with Republic Act 10863 (Customs Modernization and Tariff Act) and relevant Customs rules and regulations, you are hereby directed to seize the **entire shipment consisting of 68 cartons of mirror with frame and various general merchandise**, and turn them over to the Property Custodian/Warehouse-in-Charge, this Port, for safekeeping pending termination of the seizure proceedings thereon or until further order from this Office pursuant to and in strict compliance with the provisions of CMO 8-84 particularly on the matter of making a return of service and the submission of the Inventory Report or list of the articles seized.
